# **RESEARCH INTERESTS**

My research primarily examines discursive constructions of exclusive realities and systems of privilege. Through an interpretive/critical lens, I explore (a) exclusive and inclusive interpersonal and health communication, (b) the myriad ways communication enables, constrains, resists, and transforms our sense of the possible, and (c) communication's transformative potential to make better social worlds. I tend to examine subjects such as stigma, ostracism, bullying, social rejection, conflict management, dialogue, and deliberation. My research often takes me to realms of ethics, morality, identity, and social belonging, particularly in the contexts of interpersonal and health communication.
